
- **WA-409-P Exploration Permit renewed**
- **Primary term work commitment includes seismic reprocessing**

Cue Energy Resources Ltd (ASX:CUE) is pleased to advise that its 100% owned subsidiary, Cue Exploration Pty Ltd, has accepted an offer from the National Offshore Petroleum Titles Administrator (NOPTA) to renew the WA-409-P exploration permit, offshore Western Australia for a period of 5 years.

The renewal terms include a primary term (Years 1-3) minimum work requirement of 325km² of seismic reprocessing and associated geotechnical studies to further define the giant Ironbark prospect within WA-409-P.
